OF YOUR LETTER DEALING WITH YOUR INVESTIGATION INTO THE
ARKANSAS PRISON SYSTEM AND THE ARKANSAS PRISON BLOOD
PLASMA DONATION PROGRAM.

WITH BOTH REGARDS I BELIEVE I MAY HAVE A
SUBSTANTIAL AMOUNT OF INFORMATION FOR YOUR RESEARCH.

GIVEN THIS, PLEASE TAKE NOTE OF A SYNOPSIS IN REGARDS
TO MYSELF.

IN JANUARY 1975 I ENTERED THE ARKANSAS PRISON SYSTEM.
FROM THAT TIME AT THE CUMMINGS UNIT UP TO MY TRANSFER TO
THE MAXIMUM SECURITY UNIT IN 1983, I PARTICIPATED IN THE
PLASMA CENTER DONATION PROGRAM. SPECIFICALLY OF INTEREST,
YOU MAY WISH TO NOTE THAT I WORKED AS AN INFIRMARY
CLERK IN 1978. I ALSO HAD AND HAVE HEPATITIS B & C. MORE
IMPORTANTLY, I ACCEPTED PAYMENT TO FALSIFY MEDICAL RECORDS
SO INMATES COULD DONATE PLASMA.

AS NOTED, I WAS AT THE MAXIMUM SECURITY UNIT WHEN
IT FIRST OPENED ON JULY 5 1983. ACTUALLY, MY TRANSFER TO THE
MAX UNIT WAS ON [REDACTED] GRO-A
